Jew Business:

Attorney Myers advised that we should not have gone into executive session as we are not discussing individuals or collective bargaining. Trustee Whitson advised that previously, the Federal Government regulated drug testing for gas employees. They delegated that authority to the States. Now the Federal Government has come back in and stated that the State was not doing this correct. Our current drug testing company does not meet the Federal Government requirements. We will be switching to another company. Chief Bowsher asked if the police department should also switch. They have to be drug tested because they respond to gas calls. Attorney Myers advised that we can keep the current company for the police officers and change for the gas personnel. Chief Bowsher would like to switch to the new company as well. Consensus was to switch all employees to the new company. Attorney Myers will prepare an ordinance for the next scheduled Board meeting.
