Chris Korte-Membership Specialist and Jim Closson-Loss Control Specialist, Illinois Municipal League Risk Management Association. Korte served as primary spokesperson. Utilizing a handout encompassing RMA (Risk Management Association) services and associated financial information given to all board members, Korte gave an in-depth proposal as to why the village should consider returning to RMA. Closson explained loss control services. A short question/answer period followed with Trustee Pat Murphy asking "what is the lowest cost/figure you can offer?" Korte replied "maybe we can knock off another \$5000, however, we could not agree to that at this time." Ordinance 19-22 An Ordinance Authorizing the Village of Pawnee Establish an Administrative Adjudicatio.

Chief Harris attended the meeting pertaining to the above stated matter noting that the questions of cost and what would the village get out of the establishment of such court were never answered. Chief Harris noted that at this point he does not see this being a good thing and in the long run it is going to hurt people more and could there be a continuing rise in cost. Harris also noted that we are getting compliance with enforcement of village ordinances, most people within the village comply or try to comply. Pawnee's compliance ratio is very high. Trustee Troy Squires stated that he did not want to turn Pawnee into a Gestapo state knowing that people don't have a lot of money and compliance is high.

Motion made by Trustee Skinner to table the ordinance, and not join in the establishment of an Administrative Adjudication Court at this time, but to take at least a year to see how it goes if a court is established and then revisit the matter at that time.

- Pertaining to the abandoned house located at 700 Washington Street attorney Don Craven noted the court hearing scheduled for tomorrow, December 10. As stated by Craven, there is a new lawyer for the bank holding the property and agrees that the house should be demolished, but would like to give it to the village. The village would demolish the house and receive the lot in return. Mayor Clarke asked for a bid to demolish be obtained, if too high, village employees would take down the structure. Clarke noted that even with the cost of a dumpster, that would be the least expensive way to take title to the property for possible auction
- Zoning Committee Chair Cara Burnley noted that due to several residential/home owners complaints about water drainage from one property to another, the Zoning Board should give more thought as to where water travels due to variance requests. Mayor Clarke added that if there is any doubt about drainage, deny the variance or tax payers can take the hit.
