Personnel & Finance Committee Report: Committee Chair, Trustee Skinner

- Trustee Skinner advised the Board that the bills payable for the week ending December 23, 2014 totaled \$94,606.46. This was approved on December 8, 2014.

Gas and Water Committee Report: Committee Chair, Trustee Whitson

- Trustee Whitson advised that on December 22, 2014, 54 red letters went out. Of this, there were 8 shut offs. All have been turned back on.

- Trustee Whitson advised that gas rates for February 2015 will remain the same at \$1/therm.
- Trustee Whitson advised that he received a notice from Otter Lake Water Commission. Effective with December 2015 billing (November 2015 usage), Otter Lake will increase their rates \$.10/thousand. This is due to the installation of new high pressure pumps. The current pumps are original to water plant and 3 of them are constantly being maintenance. They have decided to install new pumps. They are predicting a cost savings of over \$45,000/year on electric. Trustees discussed passing this increase as well as infrastructure increase on to the consumer. This would start May 1. Consensus was to increase from \$17.70 to \$18.00 from .532 to .55. An ordinance will be devised for the next meeting.

Streets, Alley and Sidewalk Committee Report: Committee Chair, Trustee Condon

- Jeff Schober advised that they have been working on tiles and the railroad.

Police Committee Report: Committee Chair, Trustee Gleason

- Chief Bowsher had no report but did advise that they have recently taken part in some trainings.

Sewer and Parks Committee Report: Committee Chair, Trustee Thompson

- Trustee Thompson advised that there is a sewer main break on 13th Street. The guys have been in the hole and are repairing it. Trustee Thompson thanked the guys.
- President Clarke advised that he spoke with Jeff Schober and we are running out of shed space. He will get an estimate from Kern. President Clarke also discussed a salt barn and maybe putting the salt at one end of the shed. Jeff Schober was very interested in this.
- Trustee Thompson discussed the angel tree. He again thanked the Village and the community for the support.

- Discussed the property located at 400 8th Street. The property was sold for delinquent taxes. This is Boones lot. Attorney Meyers advised that when someone gets a tax deed, we lose our liens.

- President Clarke advised that we have received a Collective Bargaining agreement notice for request for modification. Attorney Meyers suggested modifying the agenda and going into executive session.
- President Clarke advised the Board that the Fireworks fundraiser trivia night at the KC Hall is February 7th.
- Treasurer Thein advised that she is tired of waiting on the State for the credit card machine. She was provided a number of another company. Locus is partnered with the company so it is compatible. It is called PSN and they have even more options such as online payments, smartphone apps, etc. She will find out more information on Wednesday. Consensus was that we needed more information.

- Grocery store is closing. President Clarke asked if we should pursue another grocery store coming in. Their last day is January 28, 2015. President Clarke suggested putting an ad in the post thanking them for their years of service. They will wait until after it closes.


