The power line runs down the property line and only feeds the security light. He does not want the light abandoned but would like the electrical line or street light moved. There is a 5' easement recorded in Sangamon County in 1973. Marty Hinton with REA thinks the maximum cost to move the power would be \$3,000. Consensus was that the Village is unable to pay to have the light moved, however, he could move the line and have it run diagonally. They will shut the light off for several weeks while wire is moved.
